- 5. Lunch and two snacks for the meeting and orientation shall be borne by the Division Office while transportation and related expenses shall be charged against local/school MOOE funds or other funds available subject to the usual accounting and auditing rules and regulations.
- 6. The contracted 70 enumerators for the Literacy Mapping Activities 15 working days will start on January 8, 2018 and will end on January 26, 2018.
- 7. Submission of soft and hardcopy of the Literacy Mapping Summary shall be submitted on or before January 29, 2018 at the Schools Division Office for consolidation and serve as basis for the release of remuneration of the contracted Enumerators.
- 8. Other related expenses relative to the conduct of Literacy mapping shall be chargeable against any available local funds subject to the usual accounting rules and regulations.
