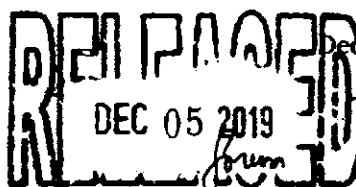

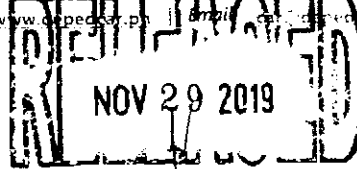

1. DepEd CAR shall hold an Advocacy Caravan on CyberSafe and CyberREADi Schools cum Launching of Project #IAMDepEdCAR on December 12, 2019 at NEAP-R, DepEd CAR RO Compound, Wangal, La Trinidad, Benguet.
