


ADDENDUM ON THE ADMINISTRATION OF PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)

To: Public Schools District Supervisors
Coordinating School Heads
Elementary and Secondary School Heads (Private & Public)

1. The schedule on the administration of the Philippine Educational Placement Test (PEPT) will be on **January 8, 2023**, below is the time table for the test

- 2. To ensure smooth conduct of the said activity, it requested to abide with the following guidelines:
 - a. For those scheduled to have the test in both sessions 2 and 3, they are encouraged to bring their lunch so they may come back on time for session 3.
 - b. Latecomers will **not** be accommodated anymore.
 - c. **No walk-in examinees** will be accommodated. Only those endorsed in the official list of the Division shall be allowed to take the test.
 - d. The test takers must bring an **ID**, the **consent form** signed by the parent or guardian, and the **lacking documents** if there are any. All of the examinees must bring **one 1x1 ID picture with a name tag** since they have initially submitted only one. Those will be checked by the personnel assigned in the waiting rooms.
 - e. The test takers should go to the comfort room before entering the testing room

- f. The test takers may practice activities related to their religious beliefs inside the testing room. The test administrators should be informed about this.
- g. The test takers must bring their own pencil/s and a sharpener.
- h. Books, mobile phones, and other educational resources are not allowed inside the testing room.
- i. The test takers who are 8 years old and above must know the following information:
- · Last Name, First Name, Middle Initial
- Birthdate
- Age (Ex. 08, 09, 10, 11, ...)
- Last Level Completed (LLC). Refer to the attached file.
- Purpose of Examination Placement
- Civil Status (Single, Married, Widowed, Separated)
- Gender/Sex (Male, Female)
- 3. Compensatory leave will be given to the Division and Benguet High Personnel who will served as facilitators to offset the Saturday (Preparation of the documents and rooms) and Sunday (actual examination) activity.
- 4. Immediate dissemination of and strict compliance is desired.
