


SUBJECT: CAPACITY BUILDING TRAINING FOR SDO-BENGUET PSYCHOSOCIAL FIRST AID (PFA) PROVIDERS IN PSYCHOSOCIAL PROCESSING (PSP)

DATE: 14 January 2019

1. The Schools Division of Benguet shall conduct a **Capacity Building Training of Psychosocial First Aid (PFA) Providers in Psychosocial Processing (PSP)** on **January 29 (Tuesday) to January 31, 2019 (Thursday)** at **Eurotel Baguio, 123 Abanao Extension Baguio City, 2600.**
2. The training-workshop aims to:
 - a. understand the basic concepts of Psychosocial Support Processing (PSP) and its application to disaster, crisis and emergencies; and
 - b. capacitate and equip both Guidance Counselors and Health Personnel as PSP Providers in the use of PSP interventions, techniques and approaches in which they can use in schools and/or community especially during emergencies and disasters.
3. Attached is the list of participants to the said training-workshop.
4. Meals, snacks and accommodation shall be charged to DRRM Response Fund for Typhoon *Omping* while travel expenses of each participant shall be charged against their respective local funds.
