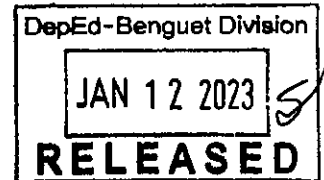

1. Pursuant to the Regional Memorandum No. 472 series 2022 also known as *Reiteration of Timelines on the Processing of Applications for Regulatory Services for both Public and Private Schools*, the Schools Division of Benguet shall conduct an **Onsite Validation and Provisions of Technical Assistance to Private Schools Applying for Regulatory Services for School Year 2023-2024 on January 16 to January 31, 2023.**
