



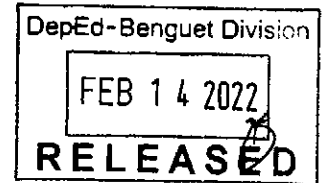

SUBJECT: **Participants to the Orientation of Master Teachers as New Learning Resource Evaluators (2 Batches) under the Capability Building of Teachers, Non-Teaching, and School Leaders on DepEd Enhanced Guidelines / Mandates Program**

1. The Division aims to continuously upgrade and sustain the knowledge and skills of all its employees due to the inevitable challenges faced by the Department brought about by the paradigm shift in the delivery of services in the system. This office, therefore, enjoins all identified participants to commit to this activity and meet the objectives until the end of the process.
2. The participants of this training are Master Teachers who shall be oriented on the following:
 - a. LRMS Processes
 - b. Social Content Guidelines
 - c. Intellectual Property Rights
 - d. Tools for LR Evaluation
3. It is expected that the participants trained in this face-to-face orientation shall lead in the establishment of the Learning Resource Management and Development System in their respective schools particularly the development and quality assurance of learning resources.
4. The participants (enclosure 1) for this orientation will be in two batches. Batch 1 will be on February 15 to 17, 2022; while Batch 2 will be on February 17, 18, and 21, 2022. Participants shall bring with them their personal or issued laptop and extension wire for use during the onsite workshop. The three days activity will start at 8:15 a.m. and will end at 5:00 p.m.
5. All participants are to be at the venue – Ecolodge, Magsaysay, Baguio City- on or before 8:00 a.m. for day 1 and 2 and shall at ALWAYS follow the minimum IATF standards for health safety. The third day of the orientation will be conducted virtually with assigned facilitators.
6. Meals and snacks shall be chargeable against 2021 HRD Fund, while transportation expenses of participants shall be chargeable against local funds subject to the usual accounting and auditing rules and regulations.
