 Pursuant to DepEd Memorandum no. 43, s. 2020 re Guidelines on the Alternative Work arrangements in the Department of Education in Light of the COVID-19 Stringent Social Distancing Measures, the School Governance and Operations Division through the Planning and Research unit in coordination with the Information and Communication Technology unit will conduct the seven day Basic and Action Research writeshop through telecommunication on April 8,13,16,20,22, 27, and 30, 2020.

#### 2. The writeshop aims to:

- Address the needs of SDO Personnel and District Research Coordinators in writing a research proposal in compliance to their Key Result Areas indicated in their Professional Competency Profile and Individual Professional Development Plan;
- Render technical assistance in groups, pairs, or individual through all possible telecommunication available;
- Continue in improving the culture of research in the Division, and advocate the DepEd Basic Education Research Agenda and DepEd Research Guidelines; and
- d. Produce and submit at least 55 research proposals for review and approval.
- 3. The Opening and orientation of the writeshop will be on April 8, 2020 at exactly 8:00am through webinar. All participants are encouraged to log-in following the schedule identified in the enclosure for relevant information are to be disseminated. The webinar link will be provided through text or messenger on or before the activity.
- 4. Participants are expected to prepare their laptop with browser/ mobile phone installed with Hangouts Meet application. PLDT Home Prepaid WIFI unit for field facilitators or Technical Working Group members shall be provided and to include the Internet / WIFI load of P300 to each participant chargeable against 2019 HRTD fund subject to the usual auditing rules and regulations.

- 5. Participants who cannot join the writeshop are requested to notify the Planning and Research Section through xylene for them not to be included in the distribution of Internet / WIFI load or PLDT Home Prepaid WIFI unit. Same condition applies to participants who will not participate in any telecommunication required for the implementation of the activity, this means, attendance and accomplishments shall be monitored.
- The participants of this activity were identified based from their Position and Competency Profile, and are representative/s of their office section/unit. Research District Coordinators and Technical Working Group from the field are also included to participate at the same time facilitate.
