- 2. To facilitate the payment of SHA, Report of Attendance for FY 2018 shall be prepared per school and be submitted to the Schools Division Office on the following dates;

- 3. Attendance in terms of SHA shall mean physical presence in the school. Leave of Absences whether with or without pay; and travel on Official Business of Official Time shall NOT be counted.
- 4. School logbooks will be required for validation of the Report of Attendance. Account names in the ATM Cards shall tally with the submitted names of qualified teachers to avoid delays in the verification of accounts. Qualified teachers shall update their account names (for any change of name) at the Land Bank of the Philippines.
- 5. School Heads shall certify the correctness of the Report of Attendance. In the Absence of a full time School Head, the Teacher-In-Charge shall be included to certify the correctness of the report to be validated by the Cluster Bookkeepers and PSDSs/District Coordinators.
- 6. Immediate and wide dissemination of this Memorandum is desired.
