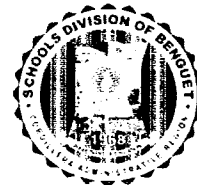

Subject: DIVISION ARNIS SPORT TRAINING-SEMINAR PHASE 2 and Accreditation of Benguet Arnis Coaches

1. There will be a four (4) day Division Arnis Training-Seminar on May 9-12, 2018 to be held at the SDO-Adivay Hall, La Trinidad, Benguet.
2. The objectives of the training are the following;

 - b. Develop skills and capabilities in coaching Arnis in preparation for the different school sports activities from the lower to higher meets.
 - c. Qualify to coach Arnis event;
 - d. Accredite the coaches.
