Subject: **Division Training of Action and Basic Research District Pool of Trainers and Technical Working Group (Phase 1)**

1. The submission of research proposals and the number of teachers signifying interest in conducting research is continuously increasing, thus requiring the need for a District Pool of Trainers and Technical Working Group.
2. To further enhance the knowledge and skills of selected trainers and members of the technical working group, a training will be held on May 31 and June 1, 2018, 8:00 am to 5:00 pm. Participants will be notified of the venue, through text or call, once finalized.
3. The district research committee, and members of the technical working group were selected with at least two of the following qualifications:
 - a. Must have submitted an approved action / basic research proposal and / or accepted completion report following the standards of DepEd Order 16, s. 2017;
 - b. Must be a subject expert or program specialist, having at least two hands-on experience in developing, writing, and implementing approved basic / action research (following DO 16, s. 2017), innovations, interventions, strategies and programs;
 - c. Must be well oriented and hands-on in manual computation, or using minitab, excel, SPSS and/or other related statistical applications necessary for treating research data; and
 - d. Must have attended the training conducted by the Division in relation to action and basic research writing.


