Second Call for Master Teachers and School Heads Action and Basic

Research Proposal for SY 2019-2020 Implementation

- 1. This is a reiteration of Division Memorandum No. 003, s. 2019, RE: Mandatory Submission of action / Basic Research Proposals for SY 2019-2020 Implementation, released last January 2019. This aims to strengthen the culture of research in the schools prioritizing interventions and improvement of practice for quality education following the Basic Education Research Agenda themes.
- 2. Research proposals must follow the format and have all the required reviewers signed the forms before its submission to the records section (refer to DM no. 003, s. 2019 attachments).
- 3. The following are the technical updates for both action and basic research which must be followed for the incoming school year based from the latest research guidelines given by the central office:
  - a. use of first person instead of third person;
  - b. introduction, context, and literature review must be argumentative and argument prominent, and laundry listing is strictly unadvisable;
  - c. proposals must not exceed 2,000 (+/- 10%) words including references but excluding timetable/Gantt chart, cost estimates, and plans for dissemination and advocacy
  - d. introduction and context and rationale should not be morethan 500 words; and
  - e. Literature review must strictly talk about the gaps that needs to be addressed.
- 4. Research must be strictly reflected in the OPCRF plan of School Heads and IPCRF plan of Master Teachers for SY 2019-2020.
