1. Pursuant to Memorandum OM-OAGA-2020-53 and Regional Memorandum No. 201 s. 2020 the SDO facilitate the creation of District Accreditation and Equivalency Readiness Test (AERT) Testing Centers to accommodate ALS Test Takers on September 2020 with fifteen test takers per room.
2. The District TROs and Division TROs will manage the registration of test takers by strictly following the AERT registration guidelines included in the Memo OM-OAGA-2020-0053.
3. The District AERT Task force headed by the PSDS with the TROs shall Initially assess the learner's Registration forms and portfolio before the Division Task force TRO will finalize test takers and monitor the conduct of the AERT for School Year 2019-2020.
4. Deadline of the registration and assessment of portfolio in the district will be on August 14,2020, to give time for the TRO & Division Team to Finally Review the learner's portfolio.
5. The District TROs shall coordinate with the School Principal of the Testing Center to assist in the identification of District AERT personnel within the school or nearby school to help in the conduct of this ALS Test. The list shall be submitted on August 25,2020.
6. Service credit shall be granted to the personnel who are involved in the AERT.
