


CALL FOR PARTICPANTS TO THE COMPUTATIONAL SKILLS DEVELOPMENT TRAINING FOR PUBLIC AND PRIVATE SCHOOLS ENTITLED, "IGNITE MY FUTURE IN SCHOOL"

- 1. Relative to the partnership forged between SDO Benguet and TATA Consultancy Services in December 2021, four batches of training for public and private school K to 12 teachers shall be conducted from June to August 2022. The training focuses on computational skills development for K to 12 teachers in all learning areas.
- 2. Objectives of this training are for the participants to:
 - Gain enough competency on computational skills that will be helpful in their delivery of learning;
 - b. Apply inputs gained as they prepare learners for 21st century skills in this new normal teaching-learning milieu; and
 - c. Actively participate in the prepared activities and ask questions relevant to the topics discussed.
