


WORKSHOP ON THE FORMULATION OF THE KALANGUYA AND KARAO **CULTURAL LEARNING STANDARDS**

To: Chief Education Supervisors of CID and SGOD PSDS/PSDI of District Heads of Bokod and Kabayan District IPEd Focal Persons of Bokod and Kabayan All Others Concerned



- 1. In line with the continuing contextualization of the curriculum, the Schools Division of Benguet through the Curriculum Implementation Division (CID) will conduct the Workshop on the Formulation of Cultural Learning Standards for the Kalanguya and Karao Indigenous Peoples on May 13-15, 2024 at the Pine Cone Lodge, Poblacion, Kabayan, Benguet.
- 2. The three-day workshop aims to:
 - a. formulate the cultural learning standards of the Kalanguya and Karao Indigenous Peoples to be included in the Benguet Division Cultural Learning Standards.
 - b. review and validate the initial outputs from previous workshops,
 - c. prepare lesson exemplars showing the contextualization of lessons from the formulated cultural learning standards, core values, activities, rituals, practices, and norms of the Benguet IPs.
- 3. The participants in this activity are the following: CID Chief-1, Education Program Supervisors-3, Public Schools District Supervisors/District In-Charge-3, District IPEd Focal Persons-2, Karao IP participants- 6, Kalanguya IP representatives-6, and secretariat-1.
- 4. The honoraria of elders and their transportation expenses, meals, snacks, and accommodation of participants for Day 1 and Day 2 shall be charged to the Indigenous Peoples Education (IPED) Program Support Fund while the transportation and other incidental expenses of non-elder participants

from the two districts and schools shall be charged to their respective local fund/MOOE subject to the usual auditing rules and regulations.


- 5. The first meal will be breakfast on day 1 while the last meal will be afternoon snack on day 3.
