CONDUCT OF REGIONWIDE STUDENT-LED SCHOOL HAZARD WATCHING AND MAPPING, and other DRR-related Activities IN CELEBRATION OF THE 2018 NATIONAL DISASTER RESILIENCE MONTH CELEBRATION

1. To further strengthen the Disaster Risk Reduction (DRR) at the school level and give emphasis to this year's NDRM theme, *KATATAGAN sa Kalamidad ay Makakamtan Kapag Sapat ang Kaalaman sa Kahandaan*, DepEd – Regional Office announces the conduct of a Regionwide Student-Led Hazard Watching and Mapping on JULY 27, 2018.
2. Please refer to attached DepEd Order No. 23, s. 2015 for the mechanics on how to conduct the Student-Led Hazard Watching and Mapping. In the event that the weather does not permit to be done outside, this may be conducted in two ways:
 - a) Classroom-based. Class Advisers with their Advisory classes may conduct hazard watching and mapping inside their classrooms with the classroom officers as lead persons. A classroom hazard map and Action Plan be submitted to the School DRRM Coordinator for consolidation and presentation to the School Head as proof of said activity.
 - b) By Grade Level or Per Building Assessment may be conducted for big schools. The SSG/SPG Adviser and/or School DRRM Coordinator may assign competent students to lead the group and ensure that an output be submitted to the School Head by the end of the activity.
3. All School Heads are also advised to see to it that the teachers will do DELIBERATE INTEGRATION OF DRR-CCA concepts in at least one subject or topic for the months of July and August. This should be supported or explicitly reflected in the DLL or DLP and an Accomplishment Report shall be submitted to the Schools Division Office by the end of August, 2018.
4. Immediate dissemination and adherence to this Memorandum is well-appreciated.
