
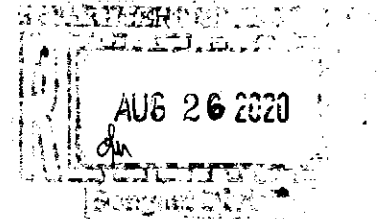

1. Pursuant to DepEd Order 21, s. 2019, the Department of Education is to implement Alternative Delivery Modes (ADMs) to make education accessible to all children in the community. These innovations are intended to make the school system more accessible and flexible especially for learners who, due to certain circumstances can't attend school on regular basis. With the presence of the COVID pandemic in the country until these times, the use of Alternative Delivery Mode (ADM) modules is very much applicable and appropriate. Thus, there is a need for teachers to continue developing Alternative Delivery Mode Modules for the third and fourth quarters in Edukasyon sa Pagpapakatao 10 on September 2, 10 and 11, 2020 thru telecommunication and work from home. This is to ensure that the most essential learning competencies for the third and fourth quarters in EsP will be developed among the learners.
 2. The activity aims to:
 - a. reorient the participants on the the preparation of Alternative delivery Mode modules;
