CREATION OF OK sa DEPED TECHNICAL WORKING GROUP (TWG) AT THE DIVISION

AND SCHOOL LEVEL

July 30, 2018

- 1. Pursuant to the implementation of DEPED Order No. 28 s. 2018, V. Strategies and Activities (A. Management and Institutional Arrangements), *OK sa DEPED* Technical Working Groups (TWG) shall be created at the Division and School Levels to be in charge of planning, coordination with partners, implementation, monitoring and evaluation.
- 2. The creation of the TWG's shall not be viewed as adding task for the members identified but as a strategy to synergize the efforts being done and roles currently being played by the members with regards to the school health and nutrition program.
- 3. The Division TWG shall be composed of the **Schools Division Superintendent** as the chairperson, and the following members:

- 4. The School TWG shall be composed of the **School Head** as chairperson and the following as members:
  - Clinic Teacher Focal Person
  - II. Guidance Counselor/ Guidance Teacher
  - III. Teacher Coordinator(s) of the School Health and Nutrition Programs (eg. SBFP Coordinator, NDEP Coordinator, ARH Coordinator, WinS Coordinator, etc)
  - IV. PTA Representative
  - V. Representative of the Barangay/LGU
  - VI. Representative from other partner agencies/Organization
- 5. Each School, through its TWG, shall be responsible in developing its own Action Plan for *OK sa DEPED* which shall be incorporated in the AIP/SIP, with technical assistance from the SDO.
- 6. Immediate dissemination to all concerned is desired.
