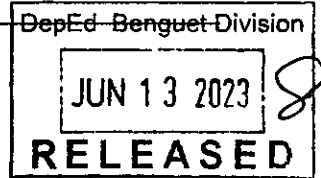

**CONDUCT OF TREE PLANTING AND CARING ACTIVITIES AS PART OF
 SCHOOLS' CLIMATE CHANGE MITIGATION INTERVENTION**

To: Public Schools District Supervisors/Coordinating Principals

 Focal Persons, Youth Formation, YES-O and DRRM
 Public and Private Schools

1. Pursuant to DepEd-CAR Regional Memorandum No. 267, s. 2023 entitled, *Conduct of Tree Planting Activities for SY 2022-2023*, **all schools** are hereby instructed to conduct Tree Planting and Tree Caring activities this month of June, 2023.

2. Further, the Tree Planting activity is also in consonance with the nationwide celebration of Philippine Environment Month as per Proclamation No. 237, dated April 4, 1988. In addition to tree planting, schools are highly encouraged to do activities connected to **#Beat_Plastic_Pollution** theme to combat plastic pollution. This can be integrated or form part of the activities in at least one learning competency within the month of June.

3. All schools that have conducted tree planting activity prior to the release of this Memorandum but within CY 2023 may consider it as compliance to this Memo. All schools are expected to accomplish their Post-Activity Report following the template provided in Annex A.
