

- 1. Pursuant to Department Order 44 s. 2021, titled Policy Guidelines on the Provision of Educational Programs and Services for Learners with Disabilities (LWDs) in the K to 12 Basic Education Program, the Schools Division of Benguet through the Curriculum Implementation Division will conduct performance/program implementation review (PIR) on July 15, 2022 at the SDO Adivay Hall, Wangal, Trinidad, Benguet.
 - 2. The activity aims to:
 - a. Foster acquaintance/closer relationship among and between the division and SPED/receiving teachers implementing inclusive education and SPED
 - b. Agree on necessary actions, activities on issues and concerns regarding inclusive education and SPED.
 - c. Prepare an inclusive education and SPED Learning Continuity Plan for the division and per district for the incoming schoolyear.
- 3. Participants in this activity are 17 female personnel composed of 14 SPED/receiving teachers from the 14 districts, one (1) representative from Benguet SPED Center, the SPED division coordinator, and a secretariat. They are identified in enclosure 1.


