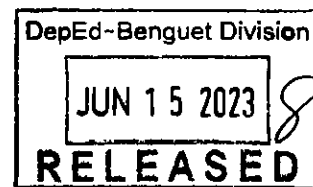

**ADMINISTRATION OF THE NATIONAL ACHIEVEMENT TEST FOR GRADE 10
(NATG10) SY 2022-2023**

To: Education Program Supervisors
Public Schools District Supervisors
Coordinating School Heads
Secondary School Heads (Private & Public)



1. Pursuant to DepEd Memorandum No. 034 s, 20232, The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), will administer the **National Achievement Test for Grade 10 (NATG12)** for the School Year (SY) 2022-2023 on **June 27, 2023**.
2. The NATG10 will be administered to sample Grade learners in all secondary schools offering Grade 10 curriculum in public and private schools through a paper-based modality.
3. The NATG10 is one of the exit assessments under the national assessment framework of the K to 12 Basic Education Program. It is designed to determine if Grade 10 learners are meeting the learning standards of the Junior High School (JHS) curriculum.
4. The test shall cover **21st Century Skills (Problem Solving, Information Literacy, and Critical Thinking)** using the area in English, Mathematics, Science, Filipino, and Araling Panlipunanan as content. The test design is progressive in nature wherein test items measure varying levels of skills in a multiple-choice format using English and Filipino language.
5. Moreover, the sampling procedure in selecting Grade 10 learners per school will be discussed during the orientation.
6. Orientation to the said activity will be at **Adivay Hall, SDO Benguet at 8:00AM on June 22, 2023**.
7. The participants to the said orientation are the **SCHOOL HEADS** with grade 10 enrolment this SY 2022-2023.


