



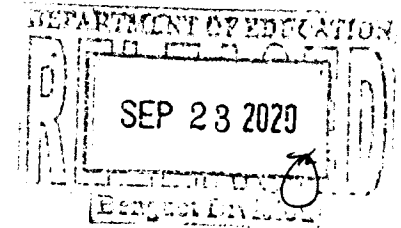

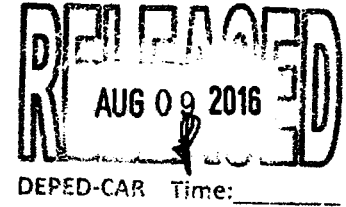

CHILD PROTECTION COUNCIL (DCPC)**

1. In relation to the Consultation among DepEd CAR key persons on child protection concerns such as child abuse, bullying, CAR, and CIGL (Regional Memorandum No. 110 s. 2016) conducted on April 29, 2016 where one of the recommendations raised was the reconstitution of Division Child Protection Committee for the division offices with established DCPC and constitution of DCPC for division offices without DCPC yet.
 2. The composition of the Division Child Protection Council is agreed to be as follows:
 - a. **The Officers**
 - Schools Division Superintendent as Chairperson
 - Assistant Schools Division Superintendent as Co-Chairperson
 - Representative per Sector as Vice Chairpersons – selected by the members of each sector (Teacher's Organization, NAPSHII, PESFA, Student Council, PTA)
 - b. **The Regular Members**
 - Legal Officer
 - Division Office Focal Person for Child Protection
 - c. **Honorary Members**
 - Provincial / City personnel in charge of the Child Protection Programs
 - d. **Secretariat**
 - To be designated by the Schools Division Superintendent
