

**REPORTING OF CONDUCTED BASIC LIFE SUPPORT AND FIRST AID (BLS-FA)
 TRAINING IN SCHOOLS, CYs 2022 to 2024**

To: Chiefs, CID and SGOD
 Public Schools District Supervisors/ Districts-in-charge
 School Heads
 Field non-teaching personnel

- Under RA 10871 or the *Basic Life Support Training in Schools Act*, it shall be the duty of all public and private basic education schools operating nationwide to provide their students with basic life support training through the use of psychomotor training in an age-appropriate manner (Sec. 3). With the Basic Life Support (BLS) Training program, participants are expected to have been equipped with life-saving skills crucial for ensuring safety in schools and communities. Through hands-on workshops, attendees gain practical knowledge and skills essential for enhancing the well-being of learners.
- Currently, the DRRMS is conducting monitoring and consolidation of conducted BLS Training in schools to effectively identify gaps and to provide necessary technical assistance concerning this activity.
- In this regard, all schools are requested to report school-initiated or school-level **BLS-FA Training from January 2022 to May 2024**. This includes those that were initiated by partner LGUs or agencies (e.g. Philippine Red Cross, BFP, PNP). Please see attached Annex A. **The deadline for submission will be on June 25, 2024, 5:00pm via electronic mail at DRRM.depedbenguet@gmail.com.**
- Immediate dissemination and compliance of all is desired.
