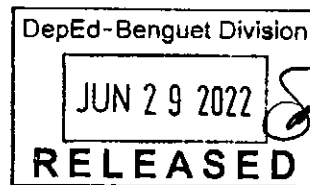

**2022 SDO BENGUET ANNUAL PRIVATE SCHOOLS' CONVERGENCE**

1. The Schools Division of Benguet shall conduct the **2022 SDO BENGUET ANNUAL PRIVATE SCHOOLS CONVERGENCE** on **July 08, 2021 (Friday), from 8:00 AM to 5:00 PM** at **Kings' College of the Philippines**. This activity will allow the Functional Divisions of SDO to present updates relative to their services and functions to private schools. Further, this will provide avenue for participants' concerns, issues and challenges encountered throughout the school year given the current global challenge. Also, the conference will provide opportunities for provisions of technical assistance and possible strategies and intervention for continuous improvement of programs, projects and activities aligned with Basic Learning Continuity Operational Plan (BLCOP).
