

CORRIGENDUM TO DIVISION MEMORANDA NOS. 202 and 203, s. 2023 (FUTURE-READY IBENGUET LEARNERS PRIMING LIFE-READY SKILLS THROUGH TECHNOLOGY IN READING AND THROUGH GAMIFICATION, RESPECTIVELY)

- 1. Relative to Division Memorandum No. 202, s. 2023 entitled, "Future-ready IBenguet learners priming life-ready skills through technology in reading," and Division Memorandum No. 203, s. 2023 entitled, "Future-ready IBenguet learners priming life-ready skills through Gamification," this Office issues this corrigendum to modify statement 3 of DM 203 and statement 5 and Enclosure 1 of both Division Memoranda.
- 2. On statement 3 of DM 203, the paragraph should read as: PSDSs and DCPs are requested to ask their respective School Heads to identify teacher participants to include 1 teacher each from grades 2 to 6 per District and 3 teachers each in SPED or those who have SPED learners per District. Preference is given to teachers without prior training in Gamification; are committed to teach for at least 5 years in grades 2 to 6; and are ready to share the inputs gained to their fellow educators through LAC sessions or INSETs.
- 3. On statement 5, DM 202 and 203 should read as: Meals (snacks and lunch) for the duration of the two training activities shall be charged against Division HRTD funds while travel and **lodging expenses** shall be charged against available local funds subject to the usual accounting and auditing rules and regulations.
