

ADMINISTRATION OF THE NATIONAL LEARNING CAMP ASSESSMENT FOR GRADE 7 AND 8 LEARNERS

- 1. Pursuant to DM-CT-2023-188 titled "Administration of the National Learning Camp (NLC) Assessment for all grade 7 and 8 public school learners for the school year 2022-2023", this office through the Curriculum Implementation Division shall commence the administration of the said assessment on June 26 to July 7, 2023 for the pre-test while the post will be scheduled on August 2023 in all the identified testing centers in the division. Please see attachment.
- 2. The schools not identified as testing centers shall coordinate with the school head of the nearby school as testing center, for more details please contact the Division ICTO, Mr Eric Wanson.
- 3. The NLC Assessment shall use the pre-test post-test design to identify the placement and effectiveness of the learning camp intervention on the learning proficiencies of participating learners before and after the attending the NLC. the assessment is an online computer-based assessment using DepEd LMS Moodle platform, which shall be administered in testing centers compliant with the technical requirements and specifications set by the DepEd Central office.
- 4. The test shall cover learning areas in English, Science and Mathematics, wherein test items measures varying level of skills in a multiple-choice format using the English language.
- 5. Guidelines for the administration was given and discussed during the online orientation of school ICT coordinators and NAT G10 orientation of school heads last June 20 and June 22, 2023 respectively.
- 6. All expenses incurred including travel expenses of learners from school to the testing center shall be charged against local funds subject to usual accounting and auditing rules and regulations.
- 7. Immediate dissemination of this memorandum is desired.
