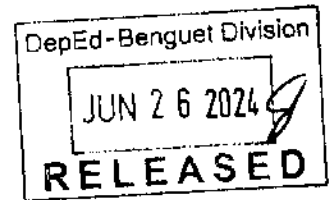



4. The meal allowance for LCV and EOSY teachers will be 250 pesos per actual day of service for the three weeks. Considering the allocated budget for the schools division, orientation will take place on the first day of the collaborative expertise session while the costs for printing NLC teaching-learning resources will be charged to the existing school MOOE funds. Additionally, internet connectivity and other expenses relative to the conduct of the said activity shall be charged to school MOOE and/or other local sources subject to the usual budgeting, accounting auditing rules and regulations.
5. Expenses incurred in the monitoring of the NLC activities by the English, Science and Mathematics supervisors and district facilitators shall be charged to the Division MOOE.
