

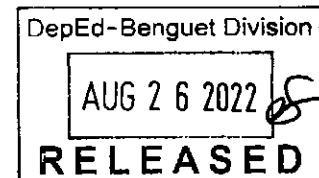

SUBJECT: THIRD QUARTER KUMUSTAHAN SA FINANCE

1. To efficiently and effectively implement the Public Bonding Law, the Bureau of Treasury release Treasury Circular No. 1-2022, dated May 30, 2022 re: *Supplemental Guidelines on the Revised Omnibus Regulations Governing the Fidelity Bonding of Accountable Public Officers (Section 313-335, Chapter 15, Revised Administrative Code of 1917)*. The circular states that accountable public officers in the NGA's, GOCCs, and LGUs supervising multiple stations in concurrent capacity shall be bonded separately. The basis of accountability and the issuance of risk number is per station.

Thus, implementation of the said circular requires application of Fidelity Bond of School Heads in the Online Fidelity Bonding System of the Bureau of Treasury and the adoption of National Government Collections and Disbursement System (NGCDS).

In line with this, The Division of Benguet under the Finance section aimed to have a convergence with the School/Mobile Bookkeepers stationed in the schools to further enlighten and expound the changes in the newly released circular for the reason that it will lead them to effectively and efficiently perform their tasks in the liquidation of school cash advances and other related responsibilities specifically in assisting their school heads on the yearly application of Fidelity Bonding.

2. The activity aims to:
 - a. Enhance knowledge and strengthen the importance of Fidelity Bond;
 - b. Implementation and adoption of the Online Fidelity Bonding System;
 - c. To be updated on the 2022 Additional School MOOE;
 - d. To foster stronger relationship and cohesiveness within the organization;and
