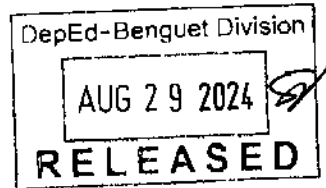

Administration of Beginning of School Year (BOSY) Rapid Mathematics Assessment (RMA) and Comprehensive Rapid Literacy Assessment (CRLA)

To: Public Schools District Supervisor/ District In-Charge
Elementary School Heads and Teachers
All Others Concerned

1. Relative to DepEd Memorandum Circular No. 2024-284, the Department of Education (DepEd) will conduct the nationwide administration of the "Rapid Math Assessment (RMA) and Comprehensive Rapid Literacy Assessment (CRLA) for Grades 1 to 3 for the beginning of the school year 2024-2025, ensuring coverage across every public school in the country.
2. The results of these assessments shall be used to:
 - a. identify learners' grade readiness and skills in reading and math skills; and
 - b. assist teachers in the design of intervention activities for this school year.
3. The RMA and CRLA are scheduled for administration from August 20 to September 20, 2024.
4. Teachers (assessors) are advised to use the updated versions of the tools. The new set of administration materials can be accessed through the links below:
