

## PROGRAM IMPLEMENTATION PLANNING AND WRITESHOP ON HEALTHY LEARNING INSTITUTION (HLI)

- 1. Republic Act 11223, or the Universal Health Care law, as well as DOH Administrative Order No. 2021-0063, or the Health Promotion Framework Strategy 2023 both mandate the designation of schools as healthy settings, hence the adoption of the Healthy Learning Institution (HLI) Framework. The HLI portfolio aims to bring together the Benguet Province Wide Health System (PWHS) and the Schools Division Office to implement a holistic series of interventions aligned with the World Health Organization's six pillars of health-promoting schools to create educational settings that are promotive of health.
- 2. Following the identification of eligible Last Mile Elementary Schools (LMES) and based on the parameters stipulated in the HLI framework, the Schools Division of Benguet in partnership with the Department of Health will conduct Orientation and School Level Action Planning for HLI Implementation on September 8, 2023 at the Adival Hall, SDO Benguet, Wangal, La Trinidad, Benguet.
- 3. Enclosure 1 contains the list of participant schools whose respective school heads and School Nurses shall attend the activity. The Public Schools District Supervisors of each district are also encouraged to take part. Each school and each nurse are required to bring a laptop to facilitate the activity.
- 4. Travel and incidental expenses, meals and snacks shall be charged against the HLI Fund subject to the usual accounting and auditing rules and regulations.
- 5. For guidance and immediate dissemination.
