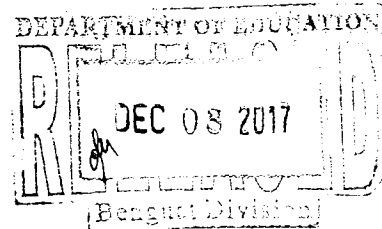


1. Phase 3 will be on December 13 to 15, 2017 at Pangil Beach Resort, Barangay Pangil, Currimaos, Ilocos Norte.


