

SUBJECT: Downloading of Program Support Fund for Special Education to Identified Public Elementary and Secondary Schools

- 1. In line with the thrust of DepEd in ensuring access to education to all types of learners, the Schools Division of Benguet is downloading fund from the Program Support Fund for Special Education (SPED) to identify schools with SPED program.
- 2. It is reiterated that the fund shall be utilized to support the programs and activities for learners with disabilities as stipulated in DM-CI-2021-00314. The program and activities include the following:
 - a. Formal assessment or rehabilitation of LWDs by medical or allied medical specialist;
 - b. Acquisition of specialized materials, devices and equipment that are intended for instructional purposes of learners with disability/ difficulty provided that the amount do not exceed Php15,000.00
 - Attendance of SPED and receiving teachers and other concerned school personnel in specialized trainings on inclusive and special education conducted by NEAP accredited service providers,
 - d. Immersion of LWDS to different work industry for possible employment and their participation to sports, academic and co-curricular activities toward holistic development and:
 - e. Communication expenses of SPED implementers subject to reimbursement and /or liquidation and existing DepEd policy on communication expenses.
- 3. These beneficiary schools as listed in Enclosure 1 shall promptly disburse and liquidate the downloaded fund in accordance with the existing auditing rules and regulations until December 31, 2021.
- 5. Immediate dissemination of this memorandum to all concerned personnel desired.
