REITERATING THE IMPLEMENTATION OF CONTINGENCY MEASURES TO COUNTER THE

DELAYED DELIVERY OF SELF-LEARNING MODULES

January 4, 2021

- Consistent with the DepEd's Basic Education-Learning Continuity Plan (BE-LCP) amid the present pandemic, the Schools Division of Benguet issued on October 12, 2020 Division Memorandum No. 205 s. 2020 entitled "General Guidelines in the Implementation of Distance Learning" and Division Memorandum 257 s. 2020 or the "Addenda to the General Guidelines in the Implementation of Distance Learning" dated November 27, 2020.
- While efforts have been exerted for the printing and eventual distribution of SLMs covering Weeks 1-4 of Quarter 2 to all schools as possible, the delivery of these on the targeted date has not been realized due to unavoidable factors. As such, the implementation of contingency measures by all schools, as provided under SDO Memorandum 257, s. 2020, is hereby reiterated:
  - a. Available textbooks, Learner's Materials and other learning resources shall be distributed to the learners through their parents or guardians. These shall also serve as reference materials for learners even when SLMs are to be given to them.
  - b. Learner's Activity Sheets/Worksheets which are aligned to the Most Essential Learning Competencies (MELCs) in each learning area shall be prepared based on the level of the learner.
  - c. Schools shall exhaust efforts to have copies of officially released video-based and audio-based teaching-learning materials from the DepEd Central Office, Regional Office or SDO Benguet and maximize the utilization of these according to the situation of each learner.
  - d. Prioritize reproduction of only the essential parts of the modules for immediate distribution.
- 3. Aside from the 'apunan' site at depedbenguet.com, schools could also access available soft copies of quality assured national and locally developed SLMs through google drive at <a href="http://deped.in/ModuleQuarter2">http://deped.in/ModuleQuarter2</a> as bases of teachers in preparing immediate activity sheets/worksheets for learners. Please take note, however, that activities found in the modules may be adjusted, reduced, and revised based on the level of abilities and situation of learners.
- 4. While strictly observing existing health protocols and guidelines, the conduct of neighborhood learning session dubbed as Adivay Para Iskuyda as per SDO Memorandum 257 s. 2020 shall only be implemented exclusively within the neighborhood or sitios where learners and teachers/facilitators reside. This is to help parents who cannot assist their children and to be able to visit learners who are at risk of failing. Remember that this undertaking is not a face-to-face class and may only be done upon the request of parents and if the situation permits.
- 5. Immediate dissemination of this memorandum is enjoined.
