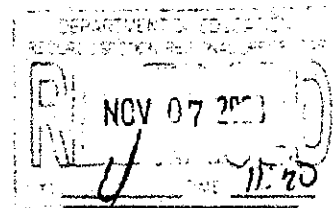

**WRITESHOP ON THE DEVELOPMENT OF DISASTER RISK REDUCTION

1. The Philippines is susceptible to geological and hydro-meteorological hazards. Being a disaster-prone country, it is imperative to raise awareness and increase knowledge, skills and attitudes, and values needed to survive any challenges due to these hazards.
2. This Office, through the Education Support Services Division (ESSD) shall conduct a writeshop on the Development of DRRM advocacy/learning materials for Grades 3 to 6 on November 14-16, 2023 (venue to be announced).
3. Each schools division shall send the following participants: 2 school heads, 1 district DRRM Coordinator/education supervisor and 1 PDO II (DRRM).
