



Greetings!

We are pleased to invite your organization to participate in our **Online Workshop on In-Depth Privacy Impact Assessments (PIA) and Framework Controls**.

As part of the workshop, participants are required to complete a **pre-work assignment**, which includes filling out the PIA template and identifying at **least 1 to 2 systems** that collect, process, or store personal and sensitive data, for registration with the **National Privacy Commission (NPC)**.

Under **NPC Circular 16-01**, Sections 4 to 6, all entities engaged in the processing of personal data are required to conduct a PIA for each program, project, or system involving such data. **NPC Circular 16-03**, Section 6, also recommends integrating PIAs into an organization's security incident management policy.

This workshop aims to equip both public and private sector participants with the knowledge and tools to effectively assess privacy risks and apply appropriate data protection measures.

**Workshop Highlights:**

- **Day 1: Overview of PIA and risk assessment principles.** Participants will map their organization's data processing activities using the information life cycle and process flow diagrams.
- **Day 2: Discussion on Data Protection Controls,** including governance structures, privacy documentation, and third-party management. Participants will draft Data Sharing Agreements (DSAs) and review consent practices.
- **Day 3: Presentation of draft PIAs.** Participants will receive feedback to improve their submissions, finalize action plans, and simulate management sign-off using sample templates.

Our registration/workshop fee is aligned with the allowable budget under National Budget Circular No. 596 dated January 20, 2025. Please see the attached guidelines issued by the Department of Budget and Management (DBM) for reference.
