

- 1. The Schools Division of Benguet Review and Evaluation Committee will conduct its Technical Assistance and Ocular Inspection of Private Schools Applying for Regulatory Services- School Year 2025-2026 on January 20-24, 2025.
- 2. The activity aims to:
  - a) provide technical assistance to school heads and administrators in preparing and submitting documentary requirements for endorsement to the Regional Office.
  - assess the schools' readiness for their program offerings in preparation for the upcoming school year.
  - c) identify challenges to serve as a basis for improving future technical assistance to private schools.


