

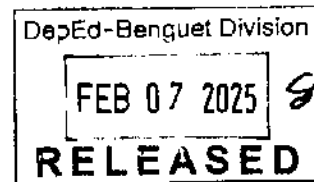

**PRESENTATION OF PROJECT PROPOSALS FOR INNOVATION
and PROVISION OF TECHNICAL ASSISTANCE TO PROJECT PROPONENTS**

1. The Schools Division of Benguet, through the Curriculum Implementation Division, will conduct the **Presentation of Project Proposals for Innovation and Provision of Technical Assistance to Project Proponents** on the following dates and venues:
 - **February 11, 2025 - Loo Elementary School, Buguias**
 - **February 20, 2025 - Buyagan Elementary School**
2. Each proponent (whether submitting a new proposal or resubmitting an unapproved one) must:
 - a. Print at least **three (3) copies** of their proposal for onsite review by the panel.
 - b. Prepare a **5-8 slide presentation**, which will be presented within a **maximum of 7 minutes**.
3. The Division Review and Evaluation Committee will provide immediate feedback and recommendations after each presentation.
4. Meals, snacks, and travel expenses for the proponents will be charged to the respective school's available funds, subject to the usual accounting procedures meanwhile the travel expenses for the SDO team to the different venues will be charged to SDO funds.
5. This memorandum will serve as the official **Travel Authority** for all presenters and the SDO Review and Evaluation Committee members listed in Enclosure No. 1.
6. Immediate dissemination and strict compliance with this memorandum are required.
