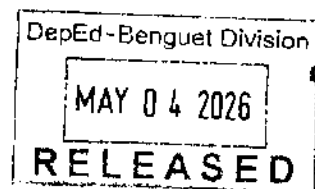

**CONDUCT OF OCULAR VISIT TO SCHOOLS APPLYING FOR OPENING FOR SENIOR HIGH SCHOOL AND INTEGRATION**

1. In line with the Department of Education’s mandate to ensure quality assurance and readiness of schools applying for the opening of Senior High School and integration, an ocular visit shall be conducted by the designated team to assess the facilities, resources, and compliance of applicant schools.

  - a. To evaluate the physical facilities and learning environment of applicant schools.
  - b. To verify compliance with DepEd standards and requirements for Senior High School implementation.
  - c. To assess readiness for integration in terms of curriculum, staffing, and support services.
  - d. To provide recommendations for approval, improvement, or deferment of applications.
