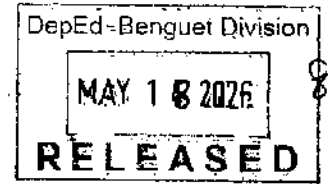

 - d. apply developmentally appropriate and play-based teaching strategies that support learners' developmental stages and foster active engagement.
 3. Registration begins at 8:00 A.M., immediately followed by the Opening Program at 8:21 A.M.
 4. Meals and snacks for participants shall be charged to the downloaded MEP Support Fund. Transportation expenses shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.
