



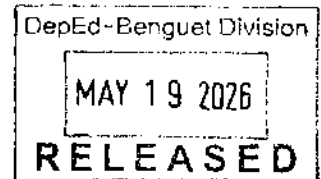

SUBJECT: **ALS TEACHERS ORIENTATION ON REVISED ALS CURRICULUM**

Anchored on Republic Act No. 11510 and aligned with the Revised Basic Education Curriculum, the updated ALS framework emphasizes competency alignment with the K to 12 system, integration of 21st-century skills, and learner-responsive instruction. To support this, there will be an **ALS Teachers' Orientation on the Revised ALS Curriculum** scheduled for **May 25-28, 2026** at **Asin Hotspring Pooten Resort, Tuba, Benguet**.
