

**DIVISION MEMORANDUM**

**Implementation of Alternative Delivery Mode for Acupan Elementary School and Accommodation of Learners from Acupan ES in Nearby Schools due to High-Risk Geohazard Classification**

1. In reference to the official assessment and geohazard evaluation conducted by the Mines and Geosciences Bureau – Cordillera Administrative Region (MGB-CAR), the community of Acupan, Virac, Itogon, Benguet—including the premises of Acupan Elementary School—has been classified as a high-risk area due to the presence of active land instabilities such as landslides, ground slumping, and other related geohazards.
2. In line with this declaration and in adherence to the Department of Education's commitment to uphold the safety, security, and overall welfare of all learners and school personnel, the following directives are hereby issued:
  - a) Effective immediately, face-to-face classes in Acupan Elementary School are suspended until further notice.
  - b) The school shall shift to Alternative Delivery Modes (ADM) including modular, online, and other flexible learning options as applicable to ensure the continuity of education while prioritizing safety.
  - c) The School Head of Acupan ES shall coordinate with SDO-Benguet for guidance on ADM implementation and school governance.
  - d) Learners who wish to attend in-person classes in nearby public schools while being enrolled at Acupan ES will be accommodated, or learners who wish to permanently transfer to other public schools within the Schools Division of Benguet will be accepted. Receiving schools are hereby instructed to accommodate learners from Acupan ES without delay, ensuring that their academic records and learning needs are appropriately addressed.
  - e) The School Head of Acupan ES, in coordination with the District Office and Municipal DRRM Focal Persons, shall conduct regular updates and maintain communication with parents and stakeholders regarding the school's status and continuity plans.
3. The Division Office remains firm in its commitment to prioritize the protection of learners and personnel, while ensuring that learning continues in a safe and supportive environment.
4. For widest dissemination and strict compliance.
