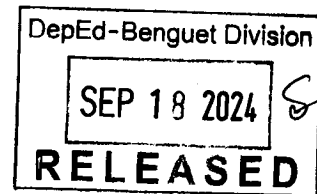

 - f. Prepares the necessary reports and ensures their timely submission
 - g. Performs other functions related to the implementation of the IPed program
