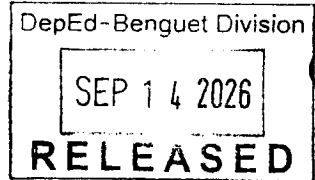

As the schools nearest to the venue, learners, teachers, and school personnel from **Benguet National High School, Cordillera Regional Science High School, Benguet SPED Center, Puguis Elementary School**, adjacent learning centers, and SDO Benguet personnel are invited to avail of the following **FREE** services:

- **PhilHealth & Primary Care:** Registration, YAKAP Empanelment, First Patient Encounter (FPE), and GAMOT Services
- **Medical & Diagnostic:** Consultations, Laboratory, X-Ray/Radiology, Dental, and Mental Health Services
- **Health Promotion:** IEC Booths, Health Promotion, and Literacy Information

3. Attendees are requested to bring a **Valid ID** and their **PhilHealth ID / MDR**.

4. Pursuant to guidelines on the wellness break, participation and availment of services shall be **voluntary**. School Heads shall ensure that attendance does not disrupt regular administrative operations or class schedules.

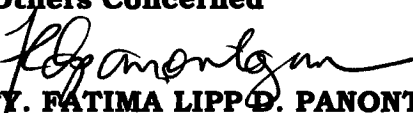

SUBJECT : **Handog ng Pangulo 2026**

DATE : August 27, 2026

In line with the directive from the Office of the President and the Department of Education's support for the nationwide initiative **Handog ng Pangulo**, all regional offices (ROs), in partnership with **PhilHealth and the Philippine Statistics Authority (PSA)**, shall facilitate **YAKAP Program activities in one school nearest to the provincial capitol** within their respective jurisdictions on **September 14, 2026**.

As the activity is scheduled during the wellness break, pursuant to DepEd Order No. 009, s. 2026, or the Guidelines on the Implementation of the Three-Term School Calendar in Basic Education, participation in the activity and availing of the services shall be **voluntary**. The services shall be made available to **learners, teachers, parents, other members of the school community, and other school personnel residing near the YAKAP Clinic who may be invited to the event**.

The Homeroom Parent-Teacher Association and the school Parents-Teachers Association may also be engaged to provide additional support or manpower during the conduct of the activity, as appropriate.

For the said event, the following services shall be made available during the activity:

- Generation of PhilHealth Identification Number and issuance of PhilHealth ID and Member Data Record;
- Assignment of beneficiaries to a YAKAP Clinic and PhilHealth Check Utility validation;
- YAKAP Empanelment, including the First Patient Encounter and issuance of the YAKAP Empanelment Slip;
- GAMOT dispensing; and
- PSA co-location services for National ID registration.

The ROs shall ensure proper coordination with the concerned **schools division offices, PhilHealth, PSA, and other relevant stakeholders** to facilitate the smooth, orderly, and meaningful conduct of the activity. They shall likewise ensure compliance with existing DepEd policies and guidelines, particularly those pertaining to the wellness break and the continuity of teaching and learning.
