



**SUBJECT: PILOT DEVELOPMENT OF DIVISION-WIDE A&E PRACTICE ASSESSMENTS FOR ALS LEARNERS**

1. In line with the Schools Division of Benguet's efforts to strengthen learner readiness for the Accreditation and Equivalency (A&E) Test, this Office will conduct the Pilot Development of Division-Wide A&E Practice Assessments for ALS Learners on October 27-29, 2025, at a venue to be announced.
2. The activity aims to:
  - a. Orient participating ALS teachers on the A&E Test framework, competencies, and structure across the six (6) Learning Strands of ALS for Elementary and Junior High School;
  - b. Capacitate ALS teachers in designing contextualized practice assessment items per learning strand aligned with the A&E Test; and
  - c. Produce draft pilot practice assessment tools in the six (6) Learning Strands that will serve as initial outputs for subsequent quality assurance and validation.
