





SUBJECT: Downloading of Program Support Funds (PSF) for the Implementation of the Alternative Delivery Mode (ADM) and Dropout Reduction Program (DORP)

1. In line with the provisions of **DepEd Order No. 21, s. 2019**, and in support of the Schools Division's initiatives to address high dropout and failure rates, an amount of **Three Hundred Fifty Thousand Pesos (P350,000.00)** from the **Program Support Fund for Alternative Delivery Mode (PSF: ADM)** has been downloaded to the **Schools Division Office of Benguet** for the implementation of the ADM Program. Of this amount, **P105,000.00** was utilized for the conduct of an **Orientation and Training Workshop** for priority schools on the implementation of ADM and DORP held last **September 22–24, 2025**. The remaining **P245,000.00** shall be downloaded to the identified priority schools.
